#### The Problem

- The objective of the UN is to ensure the enforcement of international peace and cooperation
- The objective violates the concept of state sovereignty
- The United Nations can easily intervene in a conflict where the international community is involved using its "Blue Troops"
- It struggles to enforce human right in countries that are not at war or having a civil dispute.

#### Example Case: Myanmar

- Myanmar is currently ruled by Min Aung Hlaing, who gained power through a coup in 2021
- The government has continued its persecution of Rohingya muslims
  - o 25,000 Killed
  - 700,000 displaced people
- The UN has declared it genocidal, called for trials, but has been unable to stop the persecution
